DRAFT NOTIFICATION

No..... - In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, the President of India makes the following changes in rules regulating the method of recruitment to Group 'A' posts (Non- Ministerial) in the Department of Government Rehabilitation Institute for Intellectual Disabilities, Chandigarh, namely.

1. Short title and Commencement:-(i) These rules may be called the Government Rehabilitation Institute for Intellectual Disabilities, Chandigarh, Principal (Group "A") Gazetted, Non-Ministerial Post, Recruitment Rules 2024

(ii) They shall come into force on the date of their publication in the official Gazette.

2. Application:- These rules shall apply to the posts specified in column 1 of the Schedule annexed to these rules.

3. Number of posts, Classification and scale of pay:-The number of posts, its classification and the scales of pay attached thereto shall be as specified in Column (2) to (4) of the schedule annexed to these rules.

4. Method of Recruitment, Age limit, Qualification etc:-The method of the recruitment, the age limit, qualifications and other matters shall be as specified in columns (5) to (13) of the said schedule.

5. Disqualification:- No person:-

(a) Who has entered into or contracted a marriage with any person having a spouse living,

or

(b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Administrator, Union Territory, Chandigarh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Powers to relax:-Where the Central Government is of the opinion that it is necessary or expedient so to do, he may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.

7. Saving:- Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex- servicemen and other special categories of persons in accordance with the orders issued by the Chandigarh Administration from time to time in this regard.

8. Repeal: Recruitment Rules for the post of Principal notified vide notification No.GRIID/Estt./366/2018/1100 dated 27.02.2018 are hereby repealed.
