No _____ In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi notification bearing no. S.O. no. 3267 dated 1st November, 1966, the President of India makes the following rules regulating the method of recruitment to Group 'A' Posts (Non-Ministerial) in the Department of Government Rehabilitation Institute for Intellectual Disabilities, Chandigarh namely -

1. Short title and Commencement:

- (i) These rules may be called the Government Rehabilitation Institute for Intellectual Disabilities, Chandigarh Librarian (Non-Ministerial Cadre Group 'A' Gazetted Posts), Recruitment Rules 2021.
- (ii) They shall come into force on the date of their publication in the Chandigarh Administration Gazette.

2. Application:

These rules shall apply to recruitment to the post specified in column I of the Schedule annexed to these rules.

3. Number of posts, Classification and scale of pay:

The number of said post, its classification and the scale of pay shall be as specified in Column 2 to 4 of the Schedule.

4. Method of Recruitment, Age limit, Qualification etc:

The method of the recruitment to the said posts, the age limit, qualifications and other matters concerned therewith shall be as specified in columns 5 to 13 of the said schedule

5. Disqualification: No person:

- a) who has entered into or contracted a marriage with a person having a spouse living.
- OR
- b) who having a spouse living, has entered into or contracted a marriage, with any person shall be eligible for the appointment to the said post.

Provided that the Administrator, Union Territory, Chandigarh may, if satisfied that such marriage is permissible under the personal Law applicable to such person and other party to the marriage and there are other grounds for so doing, exempt, any person from the operation of this rule.

6. Powers to relax: -

Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.

7. Savings:-

Nothing in these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by Chandigarh Administration from time to time in this regard
